# End the Year Strong with Producer Bonuses for New AI Groups Effective 10/1/22 –1/31/23

Dear Valued Producer,

To thank you for your hard work on the Industry Health Trusts offered by Associated Industries, you will be eligible for the [Regence Ignite](#) and [Asuris Advance](#) producer bonuses just in time for the fourth quarter!

For new, fully insured groups you help transition from another carrier to medical through one of the Industry Health Trusts offered by Associated Industries, you will be eligible for:

- **\$20 per subscriber** for fully insured groups with 10 or more subscribers
- **New association members** are eligible for payouts
- Payouts provided for new, fully insured group business with **effective dates between October 1, 2022, and January 31, 2023**

The subscriber count is based on the number of enrolled employees submitted with the group's case submission at the time of the initial setup.
