Producer Bonuses for New ALLtech Groups!

Regence Ignite and Asuris Advance effective 10/1/23-1/31/24

Dear Valued Producer,

With summer winding down and the fourth quarter on the horizon, ALLtech is giving you a head start on bringing new business to the Health Trust with a great new producer bonus effective October 1, 2023, through January 31, 2024. For new, fully insured groups you help transition from another carrier to the ALLtech Health Trust, you will be eligible for:

- \$20 per subscriber for fully insured groups with 10 or more subscribers

- Payouts provided for new, fully insured group business with effective dates between October 1, 2023, and January 31, 2024

The subscriber count is based on the number of enrolled employees submitted with the group's case submission at the time of the initial setup.

Continuity of Coverage Update

To support Continuity of Care (CoC) requirements federally mandated by the Consolidated Appropriations Act, 2021 (CAA), Regence Blue Shield and Asuris Northwest Health will be sending out letters to ALLtech members who have had their coverage cancelled but may continue to be eligible for benefits if they are receiving ongoing treatments.
